Parallel cinema sought to be different from the mainstream, possibly as a means of re-inventing what cinema might be. The audience from the developing middle class welcomed these films as a reflection of their life, finding that the films closely mimicked their reality. So, here is a retrospective of 50 path-breaking Hindi films made between the late 60s and mid-90s, when parallel cinema reigned in India. There is no single reason for selecting these 50 films – the primary criterion was that they were all made without the trappings of mainstream cinema and were driven more by passion than the power of money.

I hope this retrospective induces readers to rediscover these pearls of an unparalleled phase of Indian cinema.

Shringara, Srīngāra, Śrīngāra, Srīngar (love) is the dominant rasa, or aesthetic flavor, that has been interpreted in literature, philosophy, the visual and performing arts amidst other rasas - Śrīngāra (erotic), Hāsya (comic), Kāruṇyam (pathetic), Raudram (fury), Veeram (heroic), Bhayānakam (fearful), Bībhatsa (odious) and Adbhutam (marvellous), Shantam (peaceful). Spiritual love through dance is a core consciousness in the Indian subcontinent documented in the 2000-year-old Nāṭyaśāstra and shared in temple dance and sculpture since then. Such dance lexicons were culled out of western spiritual traditions over roughly the same time period. The concept of communicating unselfish, unconditional spiritual love through the metaphors of mundane human love is intrinsic to Indian aesthetic and philosophical traditions. The chapters of this book offer insights into both the shared and unique understanding and performance of shringara in various classical Indian dance traditions. ‘Nritya Kalanidhi’ Guru Lakshmi Vishwanathan kindly contributed an introductory overview of Śrīngāra in Nāṭya (communicative dance) to contextualize the focus on specific classical genres that follows.

The book is divided into two sections. The first, ‘Islamicate Histories’, charts the historical roots of South Asian Muslim cultures and the precursors of Bombay cinema’s Islamicate idioms in the Urdu Parsi Theatre, the Courtesan cultures of Lucknow, the traditions of miniature painting, poetry, song and their performance, and the various modes of story-telling that derive from Perso-Arabic traditions. The second section, ‘Cinematic Forms’, discusses the way in which these Islamicate histories are partially constitutive of the traditions of representation, performance and story-telling that give

Bombay cinema its distinctive character, traditions that have continued into Bollywood. It explores 'Islamicate' genres like the 'Oriental' film and the 'Muslim Social', as well as forms of poetry and performance like the 'ghazal' and 'the qawwali'.

Piketty guides us with elegance and concision through the great movements that have made the modern world for better and worse: the growth of capitalism, revolutions, imperialism, slavery, wars, and the building of the welfare state. It's a history of violence and social struggle, punctuated by regression and disaster. But through it all, Piketty shows, human societies have moved fitfully toward a more just distribution of income and assets, a reduction of racial and gender inequalities, and greater access to health care, education, and the rights of citizenship. Our rough march forward is political and ideological, an endless fight against injustice. To keep moving, Piketty argues, we need to learn and commit to what works, to institutional, legal, social, fiscal, and educational systems that can make equality a lasting reality. At the same time, we need to resist historical amnesia and the

temptations of cultural separatism and intellectual compartmentalization. At stake is the quality of life for billions of people. We know we can do better, Piketty concludes. The past shows us how. The future is up to us.

One of the most powerful mass movements in independent India, the Narmada Bachao Andolan (NBA) brought together thousands of people across the country from a myriad social strata and callings. The central role played by the communities of Narmada Valley, especially the Adivasis, in this decades-long struggle cannot be overstated; yet their lifelong contribution, struggles and sacrifices are neither well-recorded nor known today. This first English translation of the Marathi original *Ladha Narmadecha* bridges that gap and sees the Andolan from the eyes of the Adivasis who fought to save their forest, their land and their jeeva dori—river Narmada itself. Nandini Oza—a full-time NBA activist for over twelve years—records this untold history of the Andolan in the voices of two pivotal Adivasi leaders: Keshvbhau and Kevalsingh Vasave. Both project-affected oustees whose homes and villages were submerged by the Sardar Sarovar Dam, they talk about the history of the struggle, their own roles in it, the impact of the dam and the Andolan on Adivasi lives, the trauma of displacement and life in the resettlement sites. They talk about Adivasi culture and their sustainable, eco-friendly livelihoods on the banks of the Narmada—now lost. They interrogate the destructive development continuing for decades, and outline future challenges for the movement. Underlined by humility, candour, dignity and humour, these interviews contain vital lessons for mass movements striving to empower those on the margins of democracy. They also foreground the critical importance of oral history, and show us that listening to memory can be as much a political act as a transformational one; an invaluable volume for all activists, students of ecology, sociology, anthropology, development studies and human rights.

In this volume, veteran economist Arvind Panagariya compares two Prime Ministers' approach towards economic reforms—Atal Bihari Vajpayee and Manmohan Singh. He shows how the Vajpayee government was almost relentless in pursuit of reforms and enacted them in all areas, save a few. In his opinion, along with Prime Minister P.V. Narasimha Rao, Vajpayee 'must be credited with laying the foundation of the new India'.

Vajpayee lost the parliamentary elections of May 2004, which led to the emergence of the Congress-led United Progressive Alliance (UPA) that ruled the country till May 2014. Although Dr Manmohan Singh, who had been the finance minister when India's economy was liberalized, served as the prime minister during both these terms, reforms came to a

standstill. Social spending largely became a substitute for economic reforms. However, in its first term, the UPA did not do anything to either disrupt the prior reforms or introduce anti-growth policies. As a result, the economy grew at an 8 per cent-plus annual rate. Unfortunately, in its second term, the UPA turned outright anti-reform, taking numerous steps that eventually led to a drop in the growth rate during its last two years. Dr Panagariya analyses the reasons behind this.

This book publishes - for the most part, for the first time - Gandhi's letters to his youngest son, Devadas from 1914, when father and son were both in South Africa to 1948, when they were both in Delhi, the capital of free India where within hours of the last letter Gandhi was assassinated. Gandhi wrote these letters by day, he wrote them by night, he wrote them from aboard trains, steamers, both right and left hands being pressed into service to rest one when tired out. The letters span three decades during which the writer grew from being a fighter for the rights of Indians in South Africa to being hailed as Father of the Nation by millions in India and - opposed by many as well including the man who felled him by three bullets fired at point blank range on 30 January, 1948. The letters hold his aspirations for his son and for his nation. They bear great love and they also scorch. And we see Devadas, the recipient of the letters, move in them from compliant childhood and youth, to adulthood, questioning and remonstrating with his father and being just the independent son his father wants him to be.

Colonialism is generally understood to encompass political domination, military expansion, and economic exploitation, but the British, in their nearly two centuries of rule

over India, also achieved a thoroughgoing conquest of knowledge. In the backdrop of the Enlightenment impulse, which held that everything can be known, mapped, counted, categorized, and bounded, and the knowledge thus acquired reshaped into useable forms, the British in India created an epistemological state. *The Colonial State and Forms of Knowledge: The British in India* examines the fields and bodies of knowledge through which this state was created.

The colonial state not only produced historical, linguistic, religious, and purportedly scientific accounts of 'the people of India', but also founded organizations such as the Linguistic Survey of India and the Anthropological Survey of India, besides deploying such forms of institutionalizing knowledge as the 'report of the committee of inquiry' in their quest to know and govern India.

His driving ambition from the day he entered Parliament was to make his party the national alternative to the Congress, and this book tells the gripping story of how he achieved this ambition, becoming the first non-Congress prime minister to serve a full five-year term, paving the way for the BJP's political dominance. In many ways Vajpayee represents a bridge between the Nehruvian age and the Narendra Modi years. Spellbinding orator, coalition builder, wise statesman, benevolent father figure, Vajpayee was also a bundle of contradictions. He was both Hindutva loyalist and liberal centrist; eloquent poet and ruthless political tactician; faithful member of the puritanical Sangh Parivar who never hid his unconventional personal life. The political leader whom even his opponents dubbed 'the good man in the bad party', he became – with all his flaws and weaknesses – arguably India's most loved prime minister. Deeply researched, and with new insights and anecdotes from his closest confidants, this is the most revealing personal portrait there is of Atal Bihari Vajpayee.

In India, the modern university as a ‘teaching and examining body’ was set up as an instrument of colonial governmentality in the late nineteenth century. At that time, while many disciplines were still fluid, there was a distinct movement towards the institutionalisation of disciplinary identities in South Asia. *Disciplines and Movements* studies this historical period till a little after the end of colonialism in India through an exploration of a set of conversations and transnational encounters between Indian and German-speaking intellectuals and academicians at this time. These academics include such important names as Albert Einstein, Girindrasekhar Bose, Sigmund Freud, Swami Vivekananda, and Rabindranath Tagore. These discussions and conversations shaped the contours of disciplines such as psychology and sociology, and of course, in a different way, Indology. Moving away from the customary binary of Eastern and Western knowledge forms, the chapters show how these exchanges helped to shape and define the identity of the modern sciences and social sciences.

Correcting the course for future policy, Sen provides a new explanation of rebel retirement that will be essential to any policymaker or scholar working to end protracted insurgencies.
